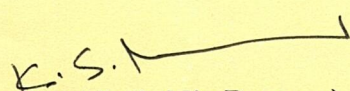

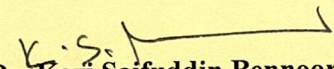

Dr. Shamrin Ahsan will travel to Maldives as a visitor. We have no objection to this visit.

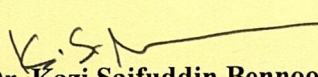
She is expected to resume his official duties upon returning to Bangladesh.
